# PPhA launches Advocacy Programs on 9 key areas

Manila, Philippines-The Philippine Pharmacists Association, Inc. through the leadership of its President Pharmacist Yolanda R. Robles has officially formed the organization's Advocacy Programs in October 2017, organized into 9 groups so far, namely: Smoking Cessation, Immunization, Pharmacy DOTS Initiative, Antimicrobial Stewardship, Pharmacy Information Services, RPh for Mental Health, Medication Adherence, Disaster Management,



and Pharmaceutical Supply Chain. This is in response to the need to develop sustainable programs for pharmacists aligned with global and regional pharmacy practice

and education, as well as the need to develop practice models that can be adopted by PPhA's local chapters.

# Former PPhA President shares the 'Soul of Pharmacy' in countries with limited resources at the 77<sup>th</sup> FIP World Pharmacy Congress

Seoul, South Korea—Former PPhA President Pharmacist Leonila M. Ocampo is one of the speakers during the plenary opening session of the 77<sup>th</sup> FIP World Pharmacy Congress held at Seoul, South Korea on September 10-14, 2017 with the theme "Medicines and beyond! The soul of pharmacy." Pharmacist Leonila shared the Philippines' experience in developing pharmacy practice

amidst the challenge of having limited resources. She highlighted how all the concentrated efforts of the Philippine Pharmacists Association contributed to the passage of the new pharmacy law which is now redefining pharmacy practice in the country, with the intention to inspire other countries by showing an example of how a strong leadership can make a big impact even in a

country where resources are considered sparse.

The plenary opening session of the FIP World Pharmacy Congress provided insights into what is the soul of pharmacy. 

# PPhA forges new partnerships in 2017 to provide opportunities for Continuing Professional Development among its members

The Philippine Pharmacists Association, Inc. has forged new partnerships in 2017 with industry providers, such as Ritemed, mClinica, PIMS and MSD to provide additional opportunities for Continuing Professional Development among its members. The Ritemed and MSD seminars were offered to more than 7,900 participants combined, providing an equivalent of 7 units and 13.5 units, respectively. Online CPD offerings were made available through mClinica and PIMS,

providing PPhA members access to 1 and 3 units, respectively.

Aside from these new partners, PPhA has continued its partnerships with UMed, catering to around 7,000 participants and Unilab, a subsidy provider for the nationwide CPD seminars, catering more than 8,000 participants from the 58 local chapters of PPhA, both providing 7 CPD units each.

These CPD activities also allowed the organization to provide a variety of formats,

such as face-to-face seminars with evaluation, face-to-face seminars with workshops, online modules with tests, combination of lectures and skills development, and self-study with lecture and skills development.

These efforts also resulted to the expansion of the Bureau of Speakers for CPD. PPhA is showing its commitment to ensure the professional development of its members. In the first quarter of 2018, competency-enhancement activities were also provided

to the expanded membership of the Bureau of Speakers.

partnerships with Future other companies such as Pharmalink, Pfizer, GSK and MIMS are being formed. Partnerships with universities, such as St. Louis University, in Baguio City and Mariano Marcos State University, in Ilocos Norte are also on its way. # PPhA 2017 National Convention highlights changes in Pharmacy Practice

The Philippine Pharmacists Association, Inc. With the theme "Filipino Pharmacists Embracing the Challenge of Change", the 2017 national convention featured discussions emphasizing how pharmacists can manage changes

in their profession. The convention also aimed to enhance the pharmacists' competencies in embracing their new roles in the healthcare system.

Bronwyn Clark, Chief Executive Officer of the Australian Pharmacy Council, delivered the keynote address entitled "Transforming the Pharmacist Workforce for Better Health for All". During the welcome reception and fellowship night, the PharmaSing and

of the PPhA led the discussion on policy formulation with his presentation on Pharmacists: Engaging Communities for Health. The program also served as venue for the YPG-Phils. to promote the FAPA Congress 2018 which will be held on Oct. 24 to 27, 2018 at the Philippine International Convention Center.

...continued on page 7 In light of new regulations, as well as the recently passed Pharmacy Law of 2016 (RA 10918), came the need to clarify the profession's roles and engagements in the health system. Pharmacist Yolanda Robles outlined a road map to serve as a guide for each advocacy group beginning with the identification of the advocacy, followed by the development of a pilot program, creating a program package and a practice model, which will then be presented to relevant stakeholders, then adopted by interested local chapters, which will eventually lead to a change in the pharmacy profession.

Pharmacist Robles also outlined the rationale for creating these advocacies as follows:

- PPhA needs sustainable programs which are led by responsible and passionate leaders
- Rationale for programs needs to be clarified prior to their development
- Recruitment of similar-minded individuals with number is strength and increased capacity to develop quality programs
- Linking with both external and internal groups with similar advocacy
- Recognition of the roles and contributions of a pharmacist in specific advocacies
- Intermediate goal is to create practice models



#### Regional Training of Trainers for Immunizing Pharmacists held in Mindanao

The Philippine Pharmacists Association, through the pharmacy-immunization advocacy group, conducted its first regional training for the first batch of trainers in San Pedro College, Davao City on April 14-15, 2018. Seven participants from San Pedro College and three representatives from the University of Immaculate Conception attended the

training led by resource trainers Karen Grace E. Romero, Enrique Romero and Arlene Si, US-certified immunizing pharmacists and core trainers from UP College of Pharmacy, Prof. Imelda G. Pena and Margarita Gutierrez. The role of the participants as trainers of future immunizing community pharmacists was emphasized at the start of

the program. The pharmacists from Mindanao were very eager to take on the challenge of this role. They also said that they look forward to imparting what they have learned to their students especially that immunization techniques and management of Adverse Events Following Immunization (AEFI) will be part of the new phar-

macy curriculum.

After the training, the participants were invited to join the immunization advocacy team, and they responded positively. The PPhA pharmacy-based immunization program will be officially launched during the 2018 National Convention in Iloilo City.

With the PPhA's commitment to empowering Filipino pharmacists and as a response to new regulations affecting the profession, the association has been continuously striving to define and clarify the pharmacist's distinct role and engagement in the health care system. These various advocacy programs shall also pave the way for the development of practice models that can be adopted at the local chapter level.

## PHARMACY-BASED IMMUNIZATION

In the Philippines, vaccination of children and adults is governed by various laws on professional practice of different health professions, including medical doctors (RA 2382, s. 1959), nurses (RA 9173, s. 2002), and midwives (RA 7392, s. 1992). A recent addition to the list of immunizers is the pharmacist group based on the legal authority provided by the Republic Act No. 10918 or the Philippine Pharmacy Act of 2016. However, before pharmacists are allowed to administer adult vaccines in an FDA licensed pharmaceutical outlet, they need to undergo a training program on the safe administration of adult vaccines and management of AEFI with certification from a duly accredited institution by PRC.

The PPhA has been authorized by PRC to conduct the aforecited training program for trainors and for interested community pharmacists who wish to offer pharmacy-based immunization services to adult patients. The main goal of the PPhA Pharmacy-based Immunization Program is to enhance the competencies of community pharmacists who can provide adult immunization services directly in the pharmacy area.

These additional services in the community can promote access to vaccines that will help increase vaccination rates and reduce the occurrence of vaccine-preventable diseases, such as, pneumonia and influenza, which remain as the second and sixth cause of morbidity, respectively, in the Philippines.

# PHARMACEUTICAL SUPPLY CHAIN MANAGEMENT

Access to essential medicines is critical in the fulfillment of the highest attainable standard of health (WHO, 2008). # ANTIMICROBIAL STEWARDSHIP

Antimicrobial Stewardship is a coordinated program that promotes the appropriate use of antimicrobials (including antibiotics), improves patient outcomes, reduces microbial resistance, and decreases the spread of infections caused by multidrug-resistant organisms.



The Department of Health Pharmaceutical Division has initiated the inclusion of clinical pharmacy services in Antimicrobial Stewardship (AMS) Program in hospitals. The objective is to improve appropriate use of antimicrobials, which is essential for preventing the emergence and spread of antimicrobial resistance (AMR). A manual of procedures was developed in 2016 to assist and align the efforts in implementing AMS programs in Levels I, II, and III hospitals in the country. The roles and responsibilities of clinical pharmacists were defined and mandated by DOH; hence, establishing the importance of clinical pharmacists in partnership with other members of the health care team in combating antimicrobial resistance. In compliance to the timeline established by DOH, core training for AMS started in 2017. The training for pharmacists all over the country was conducted in partnership with the Philippine Society of Hospital Pharmacists. The full implementation of AMS program that would help achieve a holistic andcoordinated approach in antimicrobial stewardship shall be completed by 2022.

Recognizing the important role of pharmacists in TB management, the PPhA was awarded by USAID for the scale up implementation of the Pharmacy DOTS Initiative (PDI) in 33 sites from January 2014 to September 2016. Building on the gains of previous PDI implementation, the PPhA QCEM Chapter has successfully adopted PDI and established best practices alongside strong collaboration and coordination with their local government unit. Currently, we are a regular member of the QC TB Council that conducts regular meetings every last Monday of the month. We were also one of the prime movers for the passage of City Ordinance 2545: No Prescription, No Dispensing of Anti-TB Drugs last December 2016.



Further, realizing the gravity of co-infection between TB and HIV, the group is seeking to expand the coverage of the advocacy to include strategies and activities for HIV.

# MEDICATION ADHERENCE



TThe top causes of morbidity and mortality in the Philippines include communicable diseases, such as hypertension and diabetes, and a number of infectious diseases. These conditions have known therapy and treatment regimens, yet a significant number of diagnosed patients still suffer from their poorly controlled conditions. We understand that it is not enough that patients are able to consult a physician once or few times as they

are usually without healthcare providers, and the goal is to prevent them from being hospitalized. Adherence to prescribed medications and outcomes monitoring are key to achieving optimum therapeutic goals and preventing further damage and costs. As medication experts and accessible healthcare professionals, pharmacists are strategically positioned to support both the healthcare professionals and the patients in achieving the desired health outcomes through enabling adherence.

The team aims to develop competent and compassionate Filipino pharmacists who are committed to empowering patients in adhering to their medication therapy. Although non-adherence is driven and influenced by multiple factors, it ultimately leads to better understanding of the patients as a social being. This is why the team envisions the advocacy to foster holistic patient-centered pharmaceutical care in its strategy and execution, building its foundation through enhancing needed soft skills such as empathic communication.

Recognizing that this endeavor requires working hand in hand with other healthcare providers, the team decided to configure its early structure to priority diseases namely: **hypertension, diabetes, asthma, and communicable diseases**, in general. This shall guide the shaping of strategies for capacity building of pharmacists through in-depth understanding of standard treatment guidelines, and target health outcomes and monitoring. The team is currently developing the 'Starter kit' whilst preparing to do a series of stakeholders meeting with key medical societies and agencies to help shape the overall implementation strategy.

# PHARMACY INFORMATION SERVICES

One of the core interventions recommended by the World Health Organization to assure the rational use of medicines is to have independent and credible sources of medicines information. In achieving this, pharmacists are expected to take on the role of the medication information provider, possessing broad knowledge on all aspects of the development, manufacture, action, and use of medicines. Thus, the provision of medication information services is outlined in the Philippine Practice Act of 2016 (RA 10918) as one of the core roles of pharmacists in the health care system.



In response to the increasing recognition of the pharmacist as an information provider, the Pharmacy Information Services Advocacy was created, with the objective of improving the delivery of pharmacy information services in the Philippines. The advocacy aims to: (1) enable pharmacists to serve the information needs of patients, healthcare professionals, and other clients in different practice settings through continuing education programs, (2) develop patient education materials on priority health topics, (3) establish pharmacy information services through skilled pharmacists that will provide appropriate \, comprehensive, objective information to the public, and (4) perform research that can aid the improvement of pharmacy information services in the country.

The Philippines, a country prone to natural disasters, was ranked as the third most disaster-prone country in the 2016 World Risk Index. As a result of these disasters and emergencies, health service delivery in the country has been repeatedly disrupted - which was evidently seen during the Typhoon Haiyan, locally known as

Yolanda, in November 2013. The PPhA, as the national organization of pharmacists, was at the forefront of organizing and mobilizing pharmacists in the affected areas to help in disaster relief and management efforts. More recently, the war in Marawi also saw the rise of pharmacists stepping up to serve patients who were gravely affected by the crisis.

As trusted and accessible members of the health care team, pharmacists, most especially those in the community setting, make an excellent source of emergency care when roads are closed and patients are unable to get to the hospital to seek medical care. Pharmacists can conduct primary patient assessment and triaging, as well as provide emergency refill of medications, administer vaccinations, provide first aid, and volunteer to help at shelters. Through this advocacy, PPhA, together with the Industrial Pharmacists Association of the Philippines, Inc. (IPAP), seeks to empower pharmacists, the unsung heroes of public health, in responding to disasters and emergencies.

The Pharmacy Smoking Cessation Advocacy is a partnership program between PPhA and the University of the Philippines-College of Pharmacy with the main objective of supporting and complementing the National Tobacco Control

#### Training of Trainers organized by **Drug Information Services Advocacy Group in January 2018**

The Drug Information Services Advocacy Group organized its training of trainers seminar entitled "Empowering Filipino Pharmacists in the Effective Provision of Pharmacy Information Services" last January 22-23, 2018 at the Bayleaf Hotel, Intramuros, Manila. The event was attended by 21 pharmacists who are involved with providing health and medicines information in their own respective fields of practice. The participants who attended the session included 6 hospital pharmacists, 5 community pharmacists, 4 pharmacists in the academe, 1 in the pharmaceutical industry, 4 in publishing / health care information, and 1 in research.

The first day was targeted for contextualizing the information services practice in the Philippines. Dr. Yolanda Robles began the seminar with a discussion on skills required in pharmacy information services, summarizing the skills required into 4 major classifications: oral communication skills, written skills, skills in accessing resources, and search skills. Dr. Imelda Peña then discussed different techniques in evaluating reliability of existing sources, including both text and online references. Ms. Nina Castillo-Carandang discussed ethical issues in the provision of pharinformation services. emphasizing on the importance of the context in which, ethical decisions are made in health care. Dr. Raymond Sarmiento ended the first day's discussion with knowledge management frameworks currently available in practice, citing examples of existing electronic records, and the advantages of proper knowledge management in health care processes.

On the second day of the seminar/workshop, Prof. Parisa Aslani discussed the different services that can be offered in a Pharmacy Information Center, as well as the different requirements needed to set one up.

A series of regional trainings will be conducted starting June 2018, with the aim of activating pharmacists who are interested in this advocacy in strategic areas of NCR, Luzon, Visayas and Mindanao. This is in lieu of the PPhA's direction of setting-up a drug information service center in the future.

Professor Parisa Aslani, PhD, BPharm(Hons), MSc, G Cert Ed Stud (Higher Ed), is the Professor in Medicines Use Optimisation at the Faculty of Pharmacy, The University of Sydney. She holds a BPharm (Hons) (1990) from Kings College (University of London); MSc (in Pharmaceutics; 1995), PhD (in Pharmacy Practice; 2000) and Grad Cert Ed Stud (Higher Ed) (2001) from the University of Sydney. She has worked as a community pharmacist in the UK and Australia. Professor Aslani has been a researcher and educator in the field of consumer medicine information and adherence for the past 20 years. She has received the University of Sydney's prestigious Thompson Equity Fellowship (2013), which recognizes research excellence and aims to promote and enhance the career of academic women. #### PPhA Commits to Consensus Framework for Ethical Collaboration

Last March 22, 2018, the Philippine Pharmacists Association (PPhA) signed the agreement on the adoption of the Consensus Framework for Ethical Collaboration among patients, health professionals and the pharmaceutical industry. The agreement initiated by the Pharmaceutical and Healthcare Association of the Philippines (PHAP), with the Philippine Alliance of Patient Organizations (PAPO) as the first signatory, aims to involve other health professional organizations in the country.

The Consensus Framework for Ethical Collaboration was jointly agreed upon by global organizations - International Alliance of Patients' Organizations (IAPO), International Council of Nurses (ICN), International Federation of Pharmaceutical Manufacturers and Associations (IFPMA), International Pharmaceutical Federation (FIP) and the World Medical Association in support of high quality patient care. The framework hinges on four important ethical principles: Put patients first; Support ethical research and innovation; Ensure independence and ethical conduct; and Promote transparency and accountability. The Consensus Framework outlines some of the key areas that should be considered by all partners to help guide ethical collaborations at the individual and organizational levels.

# Embracing the Challenges in the Emerging Roles of Hospital Pharmacists in the Philippines

The role in optimizing the use of medicines in the hospital setting include reductions in medication-related adverse events. lower treatment costs, better patient outcomes, reduced length of stay readmission and reduced rates. The clinical skills and expertise of pharmacists form an integral part of delivering better services to patients. Recognizing the value of this role in health care, various efforts have been made in the Philippines to introduce clinical pharmacy services in the health care system and education. Leadership at the national level has succeeded in amending the old Pharmacy Law paving the way in asserting initiatives for clinical pharmacy in the country. This includes the revision of the undergraduate pharmacy curriculum in schools of phar-

macy; and the launching of the clinical pharmacy postgraduate program in several universities.

Philippine Pharmacists Association in partnership with the American College of Clinical Pharmacy ACCP has successfully organized the training on Pharmacotherapy and Clinical Practice Series. This was a series of learning modules in view of the need to develop a clinical competency of pharmacy practitioners in the country towards obtaining an international specialty board specialty certification pharmacotherapeutics. Themed "Moving mainstream Practice toward Clinical Pharmacy", the whole training was conducted by the ACCP faculty composed of renowned clinical practitioners and educators from prestigious schools of pharmacy in the United States.

In 2017, The Philippine Society of Hospital Pharmacists formed the Clinical Pharmacy Section Council. This group is composed of clinical pharmacy leaders from various hospitals whose role is to provide training and to share best practices in the clinical pharmacy practice. "Minimum Standards of Clinical Pharmacy", was established as a guide to practitioners in implementing clinical pharmacy in public and private hospitals.

The Department of Health Pharmaceutical Division has initiated the inclusion of clinical pharmacy services in Antimicrobial Stewardship Program in hospitals. The objective is to improve appropriate use of antimicrobials, which is essential for preventing the

emergence and spread of antimicrobial resistance (AMR). A manual of procedures was developed in 2016 to assist and align the efforts in implementing AMS programs in Level I, II, and III hospitals in the country. The roles and responsibilities of clinical pharmacists were defined and mandated by DOH, hence establishing the importance of clinical pharmacists in partnership with other members of the health care team in combatting antimicrobial resistance. In compliance to the timeline established by DOH, core training for AMS started in 2017. The training for pharmacists all over the country was conducted in partnership with the PSHP. The full implementation of AMS program that would help achieve a holistic and coordinated approach in antimicrobial stewardship shall be completed by 2022.

### 2018 PPhA Lifetime Achievement Awardee AMOR CITA M. PALLERA,

#### Pharmacist-Leader, Public Health Advocate

Mrs. Amor Cita M. Pallera has been in government service for 64 years (1951-2015) as pharmacist, pharmacy adviser to the Department of Health (DOH) Secretary, adviser to the Food and Drug Administration and as consultant for various government and

non-government agencies such as USAID and WHO. She served as the founding president of the Department of Health League of Pharmacists in 1962, which became the first affiliate organization of the PPhA. She was also awarded as the Outstanding Pharmacist in Government Hospital Service (non-regulatory) by the Philippine Pharmaceutical Association in the celebration of its Diamond Jubilee in 1995.

Among the many milestones she has achieved during her service are as follows:

- served as a member of the DOH subcommittee that worked for the establishment of the Food and Drug Administration (1963) and the legislation of R.A. 3720;
- led the preparation of standards for hospital pharmacy management in government hospitals, its subsequent training and monitoring of compliance of the different government hospitals in the country;
- worked for the creation of salary grade level 20 for hospitals with DOH Botika.
- justified the creation of the National Center for Pharmacy Access and Management (NCPAM) in 2010;
- key person in the creation of the DOH Botika in various public hospitals
- was instrumental in the creation of the Botika ng Barangay under the Office of the President
- consultant to the National Drug Policy program of DOH where she was able to recommend 20 drugs for inclusion to the medicines made available to the public



# FIP Ton Hoek Scholarship for Young Leaders Award MAC ARDY GLORIA

Each year, the International Pharmaceutical Federation (FIP) awards the Ton Hoek Scholarship for Young Leaders Award to young pharmacists for their attendance to the FIP Congress such that they will learn

firsthand the global issues affecting Pharmacy. This year, the 78<sup>th</sup> FIP World Congress on Pharmacy and Pharmaceutical Sciences will be held in September 2 to 6, 2018 in Glasgow, UK.

This year's FIP Ton Hoek Scholarship for Young Leaders Award was given to Mac Ardy Gloria. Mr. Gloria, an assistant professor from the University of the Philippines Manila, bested other aspirants to become the first Filipino recipient of this prestigious scholarship. He was recognized for his service as a pharmacy educator, technical assistant provider for his work on crosscountry analysis on medicine regulatory systems and pharmaceuticals in the Asia-Pacific region for the World Health Organization, and assisted in the formulation of 2017 – 2022 Philippine Medicines Policy, Pharmacovigilance Manual of Procedures for all MOH Public Health Programs, WHO Subnational Initiative: Technical and Executive Courses on Supply Chain Management at the LGU level, the Philippine National Formulary Manual for Primary Healthcare (8th Edition), the Philippine Practice Standards for Pharmacists Manual (PhilPSP), Counterfeit Medicines Education & Vigilance in Health Professions Education Manual and the Joint MOH-FDA Training Workshop on Risk Communication for Pharmaceuticals.

#### RODERICK L. SALENGA Pharmacist, Educator, Leader, Researcher, Public Health Advocate



# A PUBLIC DECLARATION OF THE FILIPINO PHARMACISTS' COMMITMENT TO PUBLIC HEALTH AND SAFETY

The Philippine Pharmacists Association (PPhA) is a national organization of more than 18,000 pharmacists, the mother organization of 10 affiliate organizations representing pharmacists working in different areas of practice, and 85 local chapters located in all regions of the country. In the light of the passing of R.A. 10918, also known as the Pharmacy Act of 2016, PPhA publicly declares the collective and resolute intention of pharmacists in serving the Filipino people, not only in making available safe, efficacious, quality, and affordable medicines but also in exercising their duties and responsibilities as health care professionals given the stronger mandate of the new law. The scope of practice in the law expands the role of the pharmacist to include services that will directly benefit patients and populations such as clinical pharmacy services, drug information service, patient medication counseling, health promotion and safe administration of selected adult vaccines, to name a few.

Pharmacy practice in other countries had already shown the benefits of involving pharmacists in primary health care, medication management and medication adherence interventions in terms of cost-savings and achievement of patient health outcomes. For the Philippines, there is much to be done to improve the quality of pharmacy services to be at par with global standards. It entails acknowledgment of gaps in both practice and education, a systematic approach in filling these gaps, and innovative leadership to pursue change. Change in pharmacy landscape will critically rest on strategic collaboration with the government, professional organizations, employers, patient groups and the community at large.

In our desire to optimize our contribution to health care, current reforms are being undertaken by different groups in the pharmacy sector:

- The updating of the Policies, Standards and Guidelines for Pharmacy Education to comply with ASEAN and global standards was finished under the Commission on Higher Education.
- PPhA developed standards for professional practice, the Philippine Practice Standards for Pharmacists (PhilPSP) which gained the approval of the Professional Regulatory Board of Pharmacy of the Professional Regulation Commission.
- PPhA had started advocacies that will support government health programs, such as pharmacy-based immunization, antimicrobial stewardship, mental health, Pharmacy DOTS Initiative, medication adherence, pharmacy information services, disaster management, smoking cessation, wellness and self-care
- PPhA will continuously pursue competency-building and re-tooling of pharmacists and develop specific protocols and guidelines for the initial programs it had adopted.
- It is also PPhA's priority to help strengthen the public pharmaceutical supply chain management, particularly through policy development and capacity-building.

To help the government in its health agenda, we truly need the support and guidance of our regulating government agencies. We pray that government issuances, rather than discourage, should be supportive of our mission to meet the great challenge of positive change before us.

The FDA Advisory No. 2017-131 is an issuance that warns the public against accessing unauthorized immunization programs, and other unauthorized community programs sponsored by drugstores. While PPhA agrees with the mentioned requirements of pharmacy-based immunization services, the inclusion of community-based services in the issuance may project a negative view of our efforts to support government health priorities and erode public confidence in our profession. The proper context for the issuance should have been included. In addition, there should be clear distinction between basic pharmacy services from specialized services, the latter of which will require authorization from the government agency that rightfully regulates pharmacy practice.

In a country where limited health resources should be optimized due to increasing demand and where an exodus of health professionals to other countries exists, there is a need to inspire and harness the full potentials of those who opted to stay and selflessly serve the society. As professionals educated to contribute to health care, pharmacists are now stepping up, asserting and innovating its role in response to the ever complex and changing health needs of the Filipino people.

The significant reforms in policy, legislation, education and service delivery frameworks in the recent years have posed many challenges affecting our practice of pharmacy in the Philippines. These rapid changes can easily come off as intimidating to most Filipino pharmacists. They will definitely need to acquire the new competencies demanded of them as they face public expectations when they assume their new roles and responsibilities.

But together with change comes opportunity, and as we start to work

for better health outcomes of our patients, new doors of opportunities have started to emerge. These doors open to usher in new pharmacy leaders and advocates. But why is there a need for pharmacists to be advocates for the profession? Gary Wirth, RPh, vice-president of state government affairs at the National Association of Chain Drug Stores in the US said, "To advocate means to speak up, to plead a case, to support a cause, or recommend a course of action. "We (pharmacists) all have a responsibility to contribute to the future of our profession, but it takes active involvement." (Sax, 2008). Advocacy has become an important skill in pharmacy practice so much so that the American Association of Colleges of Pharmacy has already established a task force to develop recommendations for colleges of pharmacy in preparing

faculty and students to be pharmacy leaders and advocates (McDonough, 2014). Advocacy is a skill that needs to be developed and practiced as it is an important tool through which policies and legislation can be formulated. It is only through our advocacies that we can make our voices be heard in the society and it is only through our passions that can we fight for our place in the healthcare system. Our national organization, the Philippine Pharmacists Association, has created significant innovations through the nine advocacy groups relevant to Pharmacy practice. The establishment of these groups is PPhA's way of helping us show how we can care for our patients and how we can develop as Pharmacy leaders and advocates. I urge each one of us to make leadership and advocacy #trending in our profession!
