PPhA's Steadfast Commitment to Continuing Professional Development

The PPhA CPD Seminar Kick-off, sponsored by Unilab, Inc., was held on July 12, 2024, at the MK Tan Hall, Bayanihan Unilab Center, Pasig City. The event was led by Dr. Aleth Dacanay, President of PPhA, Inc., and Mr. Mark Ryan D. Langit, PPhA Education Section Representative. It was co-hosted by the PPhA South Metro Chapter (President: Mr. Mark Anthony Ellana) and the Manila Pharmacists Society (Representative: Ms. Mary Antonette Hernando).

PPhA Backs Formation of Local Government Pharmacists Association of the Philippines

August 9, 2024, Manila — True to its theme #OnePPhA, the Philippine Pharmacists Association (PPhA) took another step toward unifying the profession with the formation of the Local Government Pharmacists Association of the Philippines (LGPAP). A courtesy meeting marking this milestone was held at the Faculty of Pharmacy, University of Santo Tomas Main Building.

The LGPAP aims to recognize pharmacists serving in Local Government Units (LGUs) and to strengthen their roles in delivering quality healthcare within the community setting.

PPhA President Dr. Aleth Therese L. Dacanay presided over the meeting, joined by PPhA General Counsel Atty. Enrico Aguinaldo. Representing LGPAP were President-elect Rashida A. Unda, RPh; Secretary-elect Hilda R. Ricafranca, RPh; and Training and Education Committee Head Maridel S. Alvero, RPh.

PPhA's Position on House Bill No. 10680

"Dispensing Physicians"

On August 14, 2024, the Philippine Pharmacists Association (PPhA), represented by its President Dean Aleth Therese L. Dacanay, Ms. Leonila M. Ocampo, and Atty. Enrico Joseph C. Aguinaldo, RPh, General Counsel, actively participated as resource persons during the hearing of the House Committee on Health, chaired by Hon. Ciriaco B. Gato, Jr. Also present at the committee hearing were representatives from the Department of Health (DOH), Food and Drug Administration (FDA), Department of Trade and Industry (DTI), the Professional Regulatory Boards of Medicine and Pharmacy, the Philippine Medical Association (PMA), and the Drugstores Association of the Philippines, Inc.

The discussion centered on House Bill No. 10680, "An Act Authorizing Licensed Physicians to Directly Dispense Medicines to Patients and for Other Purposes." In line with its commitment to safeguarding the integrity of the pharmacy profession and ensuring the safe use of medications, the PPhA representatives formally submitted the Association's position paper opposing the proposed legislation.



Subject: PPhA's Position on House Bill No. 10680 - 'Dispensing Physicians'

An Act Authorizing Licensed Physicians to Directly Dispense Medicines to Patients and for Other Purposes (Authored by Hon. Robert Raymund M. Estrella, ABONO Party-list)

Prefatory Statement:

First do no harm. But how can we avoid harm and conflict of interests, when the physicians who will prescribe the medications are also the ones to sell them?

The Philippine Pharmacists Association, Inc. ("PPhA") expresses serious concerns regarding the above mentioned bill wherein it seeks to allow physicians to directly dispense medications to patients.

PPhA most respectfully and vehemently opposes the aforementioned proposed legislation.

This proposal contradicts the Philippine Pharmacy Act (R.A. No. 10918) which mandates that only licensed pharmacists are authorized to dispense medications. The efforts of the Food and Drug Administration ("FDA") and the Philippine Regulatory Board of Pharmacy ("PRBOP") have always been geared towards the strict implementation of the Philippine Pharmacy Act (R.A. No. 10918).

PPhA Joins the "White Coat Rally" in Support of UHC

August 19, 2024, Manila — In a decisive show of solidarity, the Philippine Pharmacists Association (PPhA) stood alongside over 65 health-sector organizations to oppose the planned transfer of ₱89.9 billion in unused PhilHealth funds to the National Treasury.



Organized by the Healthcare Professionals Alliance Against COVID-19 (HPAAC), the White Coat Rally unfolded at the Guazon Hall of the Philippine General Hospital. The coalition, including former Department of Health secretaries and representatives from medical societies, allied medical professional organizations, and civil society groups, delivered a collective plea to Finance Secretary Ralph Recto to halt the second tranche of ₱10 billion scheduled on August 21, 2024, while calling for systemic reform of PhilHealth and enhanced benefits for contributors.

Representing PPhA is its President, Dr. Aleth Therese L. Dacanay was among those who read the unified appeal. The medical community emphasized that redirecting healthcare funds, notably in defiance of the Universal Health Care Act's stipulations, would undermine access to vital services, especially in a system where Filipinos still shoulder 44% of health expenses out-of-pocket.

In line with One Voice, One Heart, #OnePPhA, leaders from the community pharmacy sector met with the Philippine Pharmacists Association (PPhA) on August 20, 2024 at its National Office in Manila.

Present were PPhA President Dr. Aleth Therese L. Dacanay, former PPhA President and Council of Advisers member Leonila Ocampo, and PPhA Section Representative for Pharmacy Practice Jingle G. Diola. meeting tackled strategies strengthen community pharmacists' roles, raise standards, professional and innovate services to meet the evolving healthcare needs of the public.

Key topics included PhilHealth Engagement and Payment Claim Reconciliation, as presented by PhilHealth Vice President Walter Bacareza. He addressed ongoing challenges in claims processing and outlined initiatives aimed at streamlining procedures to reduce administrative burdens on healthcare providers, thereby enhancing their ability to deliver uninterrupted care.

A keynote session also focused on the Magna Carta for Public Health Professionals, discussed by Atty. Dr. Olarte emphasized necessity of safeguarding healthcare workers' rights, advocating for fair compensation, improved working conditions, and sufficient support to sustain a motivated, resilient workforce.

PPhA was represented in attendance by its Trustee and Immediate Past President, Ma. Gilda Saljay and Assistant Treasurer Malou Garganera. This reaffirms PPhA's continuing commitment to collaborative efforts that advance the nation's health and digital transformation goals.
